## Use Procedure

---

1. Charge the toilet holding tank with clean, clear water as instructed in the aircraft manual.
2. Use one Honey Bee™ Deodorant Pak 44 for 5 gallons (approximately 20 liters) of water initially charged into the aircraft toilet holding tank.
3. Place required deodorant paks into the toilet bowl.
4. Flush several times to dissolve.

**Note:** Toilet tank holds from 3.5-5 gallons (approximately 13-20 liters)

- The deodorant powder and solution should not be allowed to contact eyes.
- In case of accidental contact, flood with water for 15 minutes. If any irritation persists, seek medical attention.
