Use Procedure

In-Place Treatment of Toilets During A Layover of Six (6) Hours or More

- 1. Drain all toilets and rinse with water.
- 2. Place ½ gallon (1.89 Liter) of Honey Bee™ Freshener Soak 50C into a single tank (15-gallon / 56 Liters capacity).
- 3. Fill each tank to above the flapper valves with fresh water.
- 4. Flush each toilet several times and allow to dwell in the tanks until the plane is returned to service.
- 5. Drain each toilet tank, but do NOT rinse.
- 6. Charge each toilet with Honey Bee™ Toilet Deodorant prime charge solution.

Toilet Cleaning

In Place

• To control malodors, spray the work area (toilet bowl, shroud, floor and sidewalls) with a 3% solution of Honey Bee™ Freshener Soak 50C 10 minutes prior to starting work.

In shop

• Toilets and toilet parts taken to the shop for work should be sprayed down with a 3% solution of Honey Bee™ Freshener Soak 50C at least 10 minutes prior to starting work. The toilets or parts should be rinsed with high pressure water spray.

Deodorizing

 Honey Bee™ Freshener Soak 50C can be an be used for treatment of malodors in the lavatory, toilet, galley and cargo areas.

For Use in Ground Service Equipment

• One-part Honey Bee™ Freshener Soak 50C to 100 parts water should be sufficient to sweeten the rinse water in the toilet service ground equipment.
