## **Use Procedure**

SR-125A is ready for use as supplied. Surfaces must be clean, free of water, and at a temperature below 100°F. Apply a medium thick layer to sealant or coating by spray, mop, or brush. Reapply as required to prevent drying and occasionally agitate the sur-face, for 30 minutes to 3 hours, until sealant is no longer attached. SR-125A may be left on overnight to promote softening and digestion of thick sealants. Agitate loosened sealant residue with brushing and squeegee or wipe material from the surface. Reapply SR-125A, as needed, to remaining sealant and repeat the removal process. Should residues remain, they are readily removed with cleaners or wipe solvent.

SR-125A softens or removes approximately 1/16 to 1/8 inch of polysulfide per application. For difficult jobs, such as removing thick layers of polysulfide sealant, mechanically remove most of the existing sealant by non-metallic (sharpened phenolic) scraper or sturdy poly bristle brush. This avoids excess processing time and minimizes product use and waste production.

**Note:** SR-125A is not intended for sealant removal use in aircraft fuel tanks. SR-125A is ineffective for removal of silicone, fluorinated, and thioether sealants and standard aircraft paint systems, such as epoxy primer with a polyurethane topcoat.
